The provision of engineering (design, installation and commissioning) services by Coolwerkz is intended to fill the gap in demand and supply, as Coolwerkz will be able to provide a turnkey Heating, Air-conditioning and Refrigeration (HVAC&R) solution to customers, and address needs and requirements of customers. Establishing a footprint in Myanmar better positions the Group to penetrate the emerging and growing Myanmar market, while enhancing service quality and support to existing customers. The initial investment in Coolwerkz is funded through the Group's internal resources and bank borrowings and is not expected to have any material impact on the net tangible assets and earnings per share of the Group for the current financial year ending 31 December 2017.

Mr. Loh Mun Yew, the Chief Executive Officer and Executive Director of the Company, has been appointed as a director and the chairman of the board of directors of Coolwerkz.

Save as disclosed above, none of the directors, controlling shareholders or substantial shareholders of the Company and their respective associates has any interest, direct or indirect, in the incorporation of Coolwerkz, save for their shareholdings in the Company, if any.
